1. Defined Terms The term "Event" means Cosplay for a Cause currently scheduled to be held on September 27, 2025 ("Event Dates") at Proctors Theatre ("Exhibit Facility"). The Event is owned, produced and managed by Proctors Collaborative ("Fandom Fest") and Lee Parker (aka Magical Lee). As used hereinafter, the term "Organizer" means, collectively, Fandom Fest, and each of its/their respective officers, directors, agents, affiliates, representatives, employees and assigns, unless the context requires otherwise. The term "Exhibitor" means, collectively (I) the company, any other business entity, or person that applied for exhibit space rental and agreed to enter into this contract upon acceptance by Fandom Fest in the manner stated below and (ii) each of its officers, directors, shareholders, employees, confractors, agents, representatives, and/or invitees, as applicable

3. Assumption of Risks; Releases
Exhibitor expressly assumes all risks associated with, resulting from or arising in connection with Exhibitor's
participation or presence at the Event, including, without limitation, all risks of theft, loss, harm, damage or injury
to the person (including death), property, business or profits of Exhibitor exuesd by negligence,
intentional act, accident, act of God or otherwise. Exhibitor has sole responsibility for its property or any theft,
damage or other loss to such property (whether or not stored in any courtesy storage area, including without
limitation any subrogation claims by its insure). Neither Organizer nor the Exhibit Facility accepts responsibility,
nor is a bailment created, for property delivered by or to Exhibitor. Neither Organizer nor the Exhibit Facility,

Indemnification Exhibitor shall on a current basis, indemnify, defend (with legal counsel satisfactory to Fandom Fest in its sole discretion) and hold Organizer and the Exhibit Facility harmless from any and all claims, demands, suits, liabilities, damages, losses, costs, reasonable attorneys' fees and expenses, which result from or arise out of or in connection with (a) Exhibitors' participation or presence at the Event; (b) any breach by Exhibitor of any agreements, covenants, promises or other obligations under this contract; (c) any matter for which Exhibitor is otherwise responsible under the terms of this contract; (d) any yoliotion or infringement (or claim or violation or infringement) of any law or ordinance or the rights of any party under any patent, copyright, trademark, trade secret or other proprietary right; (e) any libel, slander, defamation or similar claims resulting from the actions of Exhibitor; (f) harm or injury (including death) to Exhibitor; and (g) loss or damage to property or the business or profits of Exhibitor, whether caused by negligence, intentional act, accident, act of God, theft, mysterious disappearance or otherwise. Exhibitor shall not settle or compromise any claims against Organizer without Organizer's prior written consent.

5. IN NO EVENT SHALL ORGANIZERS MAXIMUM LIABILITY UNDER ANY CIRCUMSTANCE EXCEED THE AMOUNT ACTUALLY PAID TO Fandom Rest BY EXHIBITOR FOR EXHIBIT SPACE RENTAL PURSUANT TO THIS CONTRACT. Organizer makes no representations or warranties, express or implied, regarding the number of persons who will attend the Event or regarding any other matters.

6. Qualifications of Exhibitor Fandom Fest, in its sole discretion, shall have the right to determine whether a prospective exhibitor is eligible to participate in the Event. Applicants who have not previously exhibited at a prior event hield by Organizer similar to that of the Event may be required to submit a description of the nature of their business and the items intended to be exhibited. Fandom Fest reserves the right to restrict or remove any exhibit which Fandom Fest, in its sole discretion, believes is objectionable or inappropriate. Only Exhibitors with products and/or services relating to comic books, comic strips, animation, or other related popular culture items are eligible to exhibit. No adult materials may be displayed or sold without prior written permission of Fandom Fest.

7. Assignment of Space Exhibit space shall be assigned by Fandom Fest in its sole discretion for the Event and for the Event Dates only. Any such assignment does not imply that similar space will be assigned for future events held by Organizer. Fandom Fest reserves the right to change the floor plan or to move an Exhibitor to another booth location prior to or during the Event if Fandom Fest in its sole discretion determines that to do so is in the best interest of the Event.

8. Cancellation by Exhibitor Cancellation: Generally, partial cancellation of booth space is not permitted, any partial cancellation must have the prior written consent of Fandom Fest, which consent shall be in Fandom Fest's absolute discretion. Exhibitors who cancel exhibit space more than 90 days prior to the opening day of the Event, will be refunded total due, less \$50.00. Exhibitors who cancel exhibit space less than 90 days prior to the opening day of the Event, but more than 60 days prior to the opening day of the Event, will ap a cancellation feed 150% of total due. There will be no refunds for cancellations made less than 60 days prior to the opening day of the Event. Exhibitor payment will be required.

### Cancellation by Fandom Fest

9. Cancellation by Fandom Fest If Exhibitor fails to make a payment required by this contract in a timely manner, Fandom Fest may terminate this contract immediately (and Exhibitor's participation in the Event) without further notice and without obligation to refund monies previously paid. Fandom Fest reserves the right at its discretion to refuse Exhibitor permission to move in and set up an exhibit if exhibitor is in arrears of any payment due to Fandom Fest is expressly authorized (but has no obligation, expressed or implied) to occupy or dispose of any space vacated or made available by reason of action taken under this paragraph in such manner as it may deem best, and without releasing Exhibitor form any liability hereunder. Fandom Fest may also terminate this contract effective upon written notice of termination if Exhibitor breaches any of its obligations under the contract without any obligations, expressed or implied, on Fandom Fest's part to refund any payments previously made and without releasing Exhibitor from any liability arising as a result of or in connection with such breach. If Fandom Fest removes or restricts an exhibit Which SDCC considers to be objectionable or inappropriate, no refund will be due Exhibitor.

## Cancellation of the Event

10. Cancellation of the Event If Fandom Fest cancels the Event due to circumstances beyond the reasonable control of Fandom Fest (such as acts of God, acts of war, governmental emergency, labor strike or unavailability of the Exhibit Facility) Fandom Fest shall returnd to each Exhibit or tis exhibit space rental payment previously paid, minus a share of costs and expenses incurred, in full satisfaction of Organizer's liabilities to Exhibitor. Fandom Fest reserves the right to cancel, re-name or re-locate the Event or change the dates on which it is held. If Fandom Fest changes the name of the Event, relocates the Event or change stee dates on which it is held. If Fandom Fest changes the the name of the Event, relocates the Event or change stee dates for the Event of dates that are not more than thirty (30) days earlier or thirty (30) days later than the dates on which the Event of such space to Exhibitor pursuant to the terms of this contract. 11. Exhibit Space Occupancy Hours and dates for installing, occupying and dismantling exhibits shall be those expressly specified by Fandom Fest. If Exhibitor fails to install its display in its assigned space by one hour before show opens or leaves its space unattended during the Exhibit hours, Fandom Fest shall have the right to take possession of the space and no refund will be due to Exhibitor. All exhibits must be open for business during the Event hours. Exhibitor may not dismantle the display until the Event is officially closed by Fandom Fest. Exhibitors may not assign their display space to third parties without prior written approval from Fandom Fest.

12. Listings and Promotional Materials By Exhibitor's participation in the Event, Exhibitor expressly grants to Fandom Fest a fully paid, perpetual non-exclusive license to use, display and reproduce the name, trade names and product names of Exhibitor in any directory (print, electronic or other media) listing the exhibiting companies at the Event and to use such names in Fandom Fest promotional materials. Fandom Fest shall not be liable for any errors in any listing of descriptions or for omitting any Exhibitor from the directory or other lists or materials. Exhibitor agrees that Fandom Fest may also take photographs or Exhibitor's booth space, exhibit and personnel during, before or after the open hours of the Event and use such photographs for any Fandom Fest promotional purpose.

13. Care of Exhibit Facility Exhibitor shall promptly pay for any and all damages to the Exhibit Facility or associated facilities, booth equipment or the property of others caused by Exhibitor.

### Taxes and Licenses

14. Faxes and Licenses Exhibitor shall obtain any licenses, permits or approvals under federal, state or local law applicable to its activities at the Event at its sole expense. Exhibitor shall obtain any necessary tax identification numbers and permits and for paying all taxes, license fees, use fees, or other fees, charges, levies or penalties that become due to any governmental authority in connection with its activities at the Event.

15. Copyrighted Materials Exhibitors shall not play or permit the playing or performance of, or distribution of any copyrighted material at the Event unless it has obtained all necessary rights and paid all required royalties, fees or other payments.

16. Observance or Laws Exhibitor shall abide by and observe all federal, state and local laws, codes, ordinances, rules and regulations, and all rules and regulations of the Exhibit Facility (including without limitation any union labor work rules). Without limiting the generality of the foregoing, Exhibitor shall construct its exhibits to comply with the Americans with Disabilities Act.

### Additional Terms and Conditions

17. Additional Terms and Conditions Fandom Fest has sole control over attendance policies. Except as provided to the contrary in this contract; all monies paid by Exhibitor shall be deemed fully earned and non-refundable at the time of payment. Exhibitor shall conduct itself at all times in accordance with normal standards of decorum and good taste. In addition to its right to close an exhibit and withdraw acceptance of the contract, Fandom Fest in its sole judgment may refuse to consider for participation in future events held by Organizer an Exhibitor who violates or fails to abide by the contract and any of the accompanying rules and regulations. Any amendment or modification to this contract must be in writing and signed by an authorized representative of Fandom Fest. Exhibitor may not assign this contract or any right hereunder nor may Exhibitor sublet or license all or any portion of its exhibit space without the prior written consent of Fandom Fest, which consent shall be in Fandom Fest's sole discretion. discretion

### Exhibitor Service Guide

18. Exhibitor Service Guide Approximately two months from the Event, Fandom Fest will send an Exhibitor Service Guide to the Primary Contact listed on the front of this agreement. The Exhibitor Service Guide will include information integral to participation at the Event, including but not limited to additional exhibitor rules and regulations, official contractor order forms, registration, shipping and drayage, utilities and building services, exhibitor display rules, and move-in, move-out schedules

19. Incorporation of Rules and Regulations Any and all matters pertaining to the Event and not specifically covered by the terms and conditions of this contract shall be subject to determination by Fandom Fest in its sole discretion. Fandom Fest may adopt rules or regulations from time to time governing such matters and may amend or revoke them at any time, upon reasonable notice to Exhibitor. Any such rules and regulations (whether or not included in an Exhibitor Service Guide or similar document) are an integral part of this contract and are incorporated herein by reference and shall have the full force and effect as if such rules and regulations are fully set forth herein. Exhibitor shall observe and abide by additional regulations made by Fandom Fest as soon as these additional rules or regulations are communicated to Exhibitor. This contract (including the Exhibitor Service Guide and any additional rules or regulations adopted by Fandom Fest from time to time) states the entire agreement of the parties with respect to the subject matter hereof.

20. Governing Law This contract is governed by the laws of the State of New York as applied to contracts entered into and entirely performed within such state. Exhibitor agrees that the courds located in the State of New York shall constitute the exclusive forum for the resolution of any and all disputes arising out of, connected with or related to this contract or the breach of any provision of this contract. Exhibitor waives any right to assert lack of personal or subject matter jurisdiction and agrees that venue properly lies in Schenectady, New York.

21. Character of Displays: Use of Aisles and Common Areas Distribution of samples and printed matter of any kind, and any promotional material is restricted to the exhibit booth. All exhibits shall display products or services in a tasteful manner as determined in Fandom Fest's sole discretion. The aisles, passageways and overhead spaces remain strictly under control of Fandom Fest and no signs, decorations, banners, advertising material or special exhibits will be permitted in any of these spaces except by written permission of Fandom Fest. Uniformed attendants, models and other employees rulet remain writtin the border occurring the their complexer. Any and all extending distribution must be spaces except by whiteit permission of random rest. Onnomine attendants, moders and ourse employees must remain within the booths occupied by their employees. Any and all advertising distribution must be made from Exhibitor only from within his of her booth. Equipment must be arranged so that show visitors do not stand in the aisle while examining equipment or watching demonstrations. Strolling entertainment or moving advertisements outside of an Exhibitor's exhibit space is prohibited.

## 22 Sound Advertisements

22. Sound Advertisements The use of devices for mechanical reproduction of sound or music is permitted, but must be controlled. Sound of any kind must not be projected outside of the exhibit booth. Exhibitors are specifically prohibited from employing any carnival-type attraction, animal or human, or from operating such noise-creating devices as bells, horns or megaphones. Fandom Fest reserves the right to determine sound interference with others and Exhibitor shall comply with any request by Fandom Fest to discontinue any such sound or music.

23. Fire and Safety Laws Federal, state and city Laws must be strictly observed. A full listing of these fire and safety regulations will be found in the exhibitor service guide.

24. Rights of Offset; Enforcement In the event Exhibitor is indebted to Fandom Fest, whether or not such indebtedness arises from this or any other agreement, Fandom Fest shall have the right in its discretion, to apply any refunds of exhibit booth fees properly due Exhibitor to such other indebtedness in the event legal action is filed by Fandom Fest to enforce the terms and provisions of the agreement, the prevailing party in such action shall be entitled to reimbursement of court costs and reasonable legal fees.

25. Fandom Fest will be providing to you from time to time additional materials which will specify additional
terms and conditions for your participation and/or presence at the Event. Such additional terms and
conditions (including without limitation those specified in the document entitled "General Terms and
Conditions") are hereby fully incorporated herein by reference and shall have the full force and effect as if
such terms and conditions are fully and expressly set forth herein. You hereby agree that all information
containing terms and conditions provided to you by Fandom Fest shall be deemed fully read and understood
by you and that you shall be bound by all the terms and conditions contained herein and therein.
